# Moorebank Trust Ordinance 2020 Amendment Ordinance 2022

## Long Title

An Ordinance to amend the *Moorebank Trust Ordinance 2020*.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

### 1. Name of ordinance

This Ordinance is the Moorebank Trust Ordinance 2020 Amendment Ordinance 2021.

### 2. Amendment

- 5 The *Moorebank Trust Ordinance 2020* is amended by inserting a new subclause 6(2)(c), and consequently renumbering the remaining subclauses, as follows –

10 '(c) to the extent such personal property arises from a payment made to the ACPT by the Wardens of a church in the Parish for the purpose of the ACPT investing the amount, for such purposes as a majority of the parish council may from time to time determine,'.
